



## ANBL COMMUNITY FOUNDATION

ANBL welcomes **Registered** Charities to apply for consideration in our quarterly lotteries. One winner will be selected from each zone across New Brunswick.

To qualify, the following criteria must be met:

1. be a registered charitable organization through the Canada Revenue Agency;
2. have completed an application form (below) or through [www.anbl.com](http://www.anbl.com)
3. not have been a recipient of an ANBL Community Foundation lottery in the same zone within the calendar year and not have exceeded winning more than two zones per calendar year (as of January 2017)

**Note: 100% of the proceeds must stay in the zone from which the selection was made**

ANBL will consider applications in the following manner:

- ❖ applications will be accepted during the following months: January, April, July and October
- ❖ applications received after the last day of each application month will not be considered for that specific quarterly lottery
- ❖ applications will carry forward from quarter to quarter, for one calendar year
- ❖ winners will be contacted via email
- ❖ successful winners must respond within five business days or the funds will be re-directed to the next selected organization
- ❖ payments to winning organizations will be processed within three-four weeks after selection
- ❖ ANBL will contact recipients one month after funds have been awarded requesting a short outline as to how the lottery winnings were dispersed in their zone
- ❖ ANBL reserves the right to increase or decrease the number of lotteries depending on the success and/or the feasibility of the program
